COMPANY EARNINGS RELEASES

- Neogen Corporation reported financial results for the third quarter of fiscal 2017 ended February 28. Revenues increased 15% to \$88 million; net income increased 24% to \$10.3 million compared to the comparable prior-year period. Revenues for the company's Animal Safety segment increased 8% to \$45 million compared to the prior year, aided by the May 2016 Preserve acquisition. (company press release)
- Ouro Fino Saúde Animale announced financial results for the full year 2016. The company reported sales of R\$456.6 million (\$148 million), a decline of 14.5% compared to 2015.
 Operating profit was down 81% to R\$18.8 million (\$6.1 million). (Animal Pharm)
- Parnell Pharmaceuticals reported results for the full year 2016. Revenues were A\$19 million (US\$14.6 million), an increase of 45% year-on-year. The company reported a net loss at A\$(21.7) million (US\$16.7 million) compared to a loss of A\$(13.7) million in 2015. (Animal Pharm)

COMPANY NEWS RELEASES

- IDEXX Laboratories, Inc. announced that it joined the NASDAQ-100 Index, the NASDAQ-100 Equal Weighted Index, and the NASDAQ-100 Ex Technology Index. (company press release)
- Vedco, Inc. announced a multiyear distribution agreement with Baycom Diagnostics for the
 distribution of Baycom's whole blood glycohemoglobin (A1c) diagnostic device for diabetes
 detection in dogs and cats. A1Care measures the amount of sugar bound to the hemoglobin
 in red blood cells, and provides an average blood glucose level for the 70 days prior to testing
 in cats and the 110 days prior to testing in dogs. A1Care and other Baycom product offerings
 will be available through the Vedco group of distributors. (company press release)
- The FDA is investigating four cases of canine illness that may be related to ingesting high
 levels of beef thyroid hormone, which can cause increased thirst and urination, weight loss
 and elevated heart rate, among other issues. Three cases occurred after the dogs ate a
 canned variety of food made by WellPet, and one case involved a canned food manufactured
 by Blue Buffalo; certain lots under both brands have been recalled. (AVMA Smartbrief Food Safety News)
- J-Six Enterprises announced it has acquired a pet treat manufacturing facility from Perrigo Animal Health. Financial terms were not disclosed. (Pet Business)
- **Manna Pro** announced it has acquired grooming products manufacturer **Espree** to expand its companion animal business. Financial terms were not disclosed. (*Pet Business*)
- Pet King Brands announced the launch of Zymox hydrocortisone-free ear solution and Oratene antiseptic gel for brushless oral care. (Pet Business)
- Radio Systems Corporation announced it has acquired Solvit Products, which markets
 pet products for travel, active life, therapeutic and senior care. Financial terms were not
 disclosed. (Pet Product News)
- **Hyper Pet** announced it has acquired the Aussie Naturals, Outback Jack, and Wild Eats brands from **ABO Gear**. Financial terms were not disclosed. (*Pet Business*)
- Dutch aquafeed specialist Coppens International has entered into a strategic knowledge
 partnership with Brazilian fish nutrition company Guabi. The companies anticipate that algae
 technology will be a significant focus. (Animal Pharm)
- BRAZIL Brazilian federal authorities raided numerous meatpacking companies, including
 global companies JBS SA and BRF SA, in a probe called Operation Weak Flesh. The raids
 were reportedly the result of a two-year investigation into the alleged bribery of health
 inspectors by the meat companies. The police said the investigation found evidence that
 meatpackers bribed inspectors and politicians to overlook unsanitary practices such as
 processing rotten meat and shipping exports with traces of salmonella. (Feedstuffs)
- BRAZIL Merck Animal Health announced it has closed the acquisition of a controlling interest in Vallée S.A., a leading privately-held producer of animal health products in Brazil. According to the original July 2016 announcement, Merck would acquire approximately 93% of the shares of Vallée S.A. in exchange for a payment of \$400 million, based on current exchange rates. (company press release)

 AUSTRALIA Anpario announced it has acquired its Australian distributor Cobbett for approximately Aus\$1 million (\$780,000). Cobbett has been Anpario's distributor for 20 years, supplying products to Australia, New Zealand and Papua New Guinea. (Animal Pharm)

ANIMAL HEALTH NEWS

- US SCREWWORM The USDA's Animal & Plant Health Inspection Service (APHIS)
 announced the successful eradication of the New World screwworm (NWS) from Florida.
 APHIS considers an area to be screwworm free through surveillance, which includes trapping
 flies and visually inspecting animals for signs and symptoms of NWS infestation. No new
 cases of NWS have been reported in Florida since Jan. 10. (Feedstuffs)
- US POULTRY VACCINE RESEARCH A researcher at Auburn University has developed a
 potential new vaccine for both Newcastle disease and infectious laryngotracheitis (ILT). This
 new vaccine was created by inserting a gene from the ILT virus into the B1 Newcastle
 disease vaccine, which is commonly used in broilers at one day of age. Research to evaluate
 the safety and efficacy of this new vaccine candidate is continuing. (Feedstuffs)
- US PRION DISEASE DETECTION Researchers at Iowa State University have developed a highly sensitive method of screening for protein misfolding diseases including BSE and chronic wasting disease that involves intact, living brain tissue from model animals and maintaining them as live cultures. The new process produces data much faster and at less cost than was previously possible through the study of live model animals. The researchers have dubbed the process "OSCAR," short for Organotypic Slice Cultures and RT-QuIC. The research was published in Scientific Reports. (Feedstuffs)

How time flies! There is only one week left to generate revenue in the first quarter of 2017. The feedback we have from the field is that the year is off to a good start. The companion animal market appears to be outpacing the food animal sector in revenue growth, but that is expected with the current soft agricultural economy. However, the good news in the beef area is that the herd is rebuilding faster than was anticipated, so there are a few million more animals to treat versus 2015 & 2016. Producers may move to lower-priced options during this period but compliance should remain reasonably positive.

We'd like to encourage our readers in the food animal business to attend the Animal Agricultural Alliance Stakeholders Summit in early May. This organization provides a communications bridge between animal agriculture and consumers with positive messages on the values of animal agriculture.
